「2026 第二屆臺灣國際模擬聯合國會議」簡章

一、活動緣起

模擬聯合國(Model United Nations·MUN),是一項國際學術交流活動。全球許多國家、城市和學校都有自己的模擬聯合國俱樂部或舉辦過相關活動。臺灣重視多元化教育和國際融合,也開始透過青年論壇和研討會舉辦模擬聯合國會議。臺灣近百所大學和高中成立了模擬聯合國社團,突顯了模擬聯合國的重要性。在模擬聯合國中,參與者扮演非本國代表的角色,參與談判和討論。參與者須扮演不同國家的外交官、跳脫個人的視角,站在本國的立場看待問題。他們必須仔細判斷決策將如何影響國家利益,考慮國家的立場,發表聲明並模擬政策。最後,參與者必須與其他國家的代表進行談判以達成共識。

本活動由龍騰文化事業股份有限公司、財團法人商業發展研究院共同主辦,中華民國台灣模擬聯合國學會協助學術指導,旨在透過模擬聯合國討論培養學生的國際視野、同理心和跨文化溝通技巧。透過模擬國際會議程序,學生可以了解程序規則的重要性,培養國際知識、技能和國家使命感,並增強國際競爭力。學生將作為外交官分析國際時事,訓練批判性思維、反思、多元化視角以及參與全球行動的能力。

活動為期兩天,包括四個議程。第一天包括開幕式、培訓課程和兩個議程。培訓課程將介紹模擬聯合國,讓參與者熟悉議會程序、研究和資料收集技術,並練習起草會議文件。第二天包括第三次和第四次議程。所有會議和課程結束後,將舉行合影、閉幕式和頒獎典禮。所有會議主題均與永續發展目標(SDGs)一致,並與聯合國和國際委員會的主題相關,重點關注經濟發展、產業創新、公平正義和夥伴關係。

- (一) 會議採模擬聯合國的方式進行討論·著正裝並以全英文發表·仿效聯合國及相關國際機構,參考國際會議的議事規則,針對全球議題進行討論。
- (二)會議中,主辦單位將擔任主席與司儀主持會議,參與者須扮演他國外交官,模擬他國立場,藉由公開演說闡述代表國家的立場、透過辯論或遊說整合各國意見並執行大會議事規則實踐民主投票,最後再模擬撰寫決議文。
- (三) 參與者需於填寫報名表單時上傳「參加動機」PDF 檔,以利主辦方認識參與者及進 行篩選。

字數限制:使用英文撰寫500字以內。

<u>Topic 1</u>: Harnessing Artificial Intelligence for Inclusive Economic Growth through the WTO Framework

Category: International Trade and Economic Development

Committee: World Trade Organization, WTO

Introduction: Artificial intelligence is transforming the global economy by reshaping industries, trade flows, and patterns of innovation. Within the framework of the World Trade Organization, discussions on AI increasingly focus on ensuring that technological progress fosters inclusive and sustainable economic growth rather than deepening inequalities between and within nations. Delegates are encouraged to consider how AI impacts commerce, cross-border services, intellectual property rights, and market access, while also addressing the challenges faced by developing economies in integrating AI into their growth strategies. The WTO will explore cooperative approaches and regulatory mechanisms that promote innovation, inclusivity, and fair competition in the digital era.

議題簡介:人工智慧(AI)正廣泛應用於恐怖主義及反恐領域,涵蓋從監控技術、預測分析到金融監測及網路防禦等多個面向。雖然AI具備強化國際安全的巨大潛力,但同時也帶來經濟、倫理與法律層面的深刻挑戰。在經濟面向上,這些挑戰包括資源分配、AI 遭濫用於資助或支持恐怖活動的風險,以及各國間技術能力的落差。在聯合國大會全體會議中,與會代表將討論國際社會如何建立合作的法律與安全框架,規範AI在反恐行動中的負責任使用,確保經濟穩定、人權保障,並進一步維護國際法治秩序。

<u>Topic 2</u>: Addressing the Economic and Security Implications of Artificial Intelligence in Counter-Terrorism

Category: International Security and Legal Cooperation

Committee: United Nations General Assembly Plenary, UNGA Plenary

<u>Introduction</u>: Artificial intelligence is increasingly deployed in the field of terrorism and counterterrorism, from surveillance technologies and predictive analytics to financial monitoring and cyber defense. While AI offers significant potential in strengthening international security, it also raises profound economic, ethical, and legal challenges. The economic dimension includes the allocation of resources, the potential misuse of AI in financing or supporting terrorist activities, and disparities in technological capacity between states. Within the General Assembly Plenary, delegates will discuss how the international community can develop cooperative legal and security frameworks to regulate the responsible use of AI in counter-terrorism, ensuring economic stability, the protection of human rights, and the upholding of the international rule of law.

2026 2nd Taiwan International Model United Nations (TIMUN) Conference Prospectus

I. Background

Model United Nations (MUN) is an international academic activity that simulates the operation of the United Nations. Many countries, cities, and schools worldwide have their own MUN clubs or hold similar conferences. In Taiwan, where diversified education and global engagement are emphasized, more and more youth forums and academic events are adopting the MUN format. Nearly a hundred universities and high schools in Taiwan have established MUN clubs, underscoring the growing significance of this form of experiential learning.

In MUN conferences, participants take on the roles of diplomats from countries other than their own, engaging in negotiation and debate from their assigned country's perspective. They must understand national interests, formulate policy statements, and simulate the decision-making process of international diplomacy. Through this process, participants cultivate analytical, communication, and collaboration skills vital for global citizenship.

This event is co-organized by Longteng Education Co., Ltd. and the Commerce Development Research Institute (CDRI), with academic support from the Taiwan Model United Nations Association (TMUNA). The conference aims to foster students' global vision, empathy, and intercultural communication skills through simulated international dialogues. Participants will gain practical experience in global issues, procedural rules, and collaborative problem-solving — all key to strengthening international literacy and competitiveness.

The two-day event features four formal sessions. Day 1 includes the opening ceremony, training sessions, and the first two simulation sessions. Day 2 consists of the remaining sessions, followed by the closing ceremony and awards presentation. All conference themes are aligned with the United Nations Sustainable Development Goals (SDGs) and are related to the mandates of UN and international committees, with a particular focus on economic development, industrial innovation, social justice, and global partnerships.

The WTO will explore cooperative approaches and regulatory mechanisms that promote innovation, inclusivity, and fair competition in the digital era.

Topic: Addressing the Economic and Security Implications of Artificial Intelligence in Counter-Terrorism

Introduction: Artificial intelligence is increasingly deployed in the field of terrorism and counter-terrorism, from surveillance technologies and predictive analytics to financial monitoring and cyber defense. While AI offers significant potential in strengthening international security, it also raises profound economic, ethical, and legal challenges. The economic dimension includes the allocation of resources, the potential misuse of AI in financing or supporting terrorist activities, and disparities in technological capacity between states. Within the General Assembly Plenary, delegates will discuss how the international community can develop cooperative legal and security frameworks to regulate the responsible use of AI in counter-terrorism, ensuring economic stability, the protection of human rights, and the upholding of the international rule of law.


